For privacy reasons, the sponsor may enclose these documents in a sealed envelope marked "Form I-864: To Be Opened Only by a U.S. Government Official". An affidavit of support cannot be submitted electronically. These guidelines are based on the current poverty guidelines published by U.S. Department of Health and Human Services (HHS). To support an intending immigrant and his/her family members, the sponsor (s) must generally show that their income level is above 125% of the U.S. poverty line for the family unit.
